Notification No. 17/2017-GST

In exercise of the powers conferred by sub-rule (4) of rule 3 of the Jammu and Kashmir Goods and Services Tax Rules, 2017 read with section 168 of the Jammu and Kashmir Goods and Services Tax Act, 2017 (referred to as "the Act" hereafter), on the recommendations of the Council, the period for intimation of details of stock held on the date preceding the date from which the option to pay tax under section of the Act is exercised in FORM GST CMP-03 is extended till 31stOctober, 2017.
