

- a) Academic Qualification Certificate.
- b) Matriculation/ Date of Birth Certificate.
- c) Health Certificate issued by Chief Medical Officer.
- d) Domicile Certificate issued by the Competent Authority.
- e) Certificate from the concerned authorities to the effect that no loan under self-employment scheme has been taken by the appointee concerned.
- f) Migrant Registration Certificate.
- g) Migrant Registration Certificate issued by Competent Authority.
- h) Undertaking in prescribed format as communicated by CID vide communication(s) referred to above.

The appointment of the above candidates shall further be subject to the following conditions that:-

- 1. The appointees shall execute an agreement in the "Form" prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30.12.2009.
- 2. The appointees shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his Academic/Technical (if any) certificates wherever applicable he has no right to claim his appointment as Sub-Inspector as such shall be deemed to have been cancelled *ab-initio*.
- 3. If on verification, the certificates produced by the appointees are proved to be fake or forged or the institution is not recognized the appointment shall be cancelled **ab-initio**.
- 4. The salary of the appointees shall not be drawn and disbursed to him until and unless satisfactory report about his genuineness of his academic/technical/registration certificates is received from the concerned quarters.
- 5. The appointees shall be on probation for a period of 02 years during which he shall have to qualify the departmental examination (Excise & Taxation Part-I Departmental Examination).
- 6. The appointment of candidates shall be governed by the "New Pension Scheme" as per SO 400 of 2009 Dated: 24.12.2009.
- 7. The fixation pay and allowances and the conditions of probation of the appointees shall be governed in terms of SO 194 dated: 17.06.2020 as provided under Government order No. 586-JK(GAD) of 2021 dated: 07-07-2021.
- 8. The inter-seniority of the appointees shall be in the order of merit of the Selection List issued by J&K Service Selection Board vide No. SSB/Sel/Secy/M/02/2021/6307-13 dated: 23-09-2021.
- 9. The appointment is subject to outcome of any writ petition(s) pending in any court of law of the competent jurisdiction and verification report from the Relief Rehabilitation Commissioner, Migrant for Migrant/Category/Domicile certificates of the appointees.
